# 401(k) Commencement of Auto Enroll

Thank you to those who were able to attend one of the 401(k) Educational Sessions in person or via Zoom. During the 401(k) Educational Sessions we also announced the commencement of the Automatic Enrollment (Auto Enroll) feature that will be added to the plan effective 1/1/2024. If you already have a deferral election set up in the Integrits Corporation 401(k) Plan, this new feature will have no effect on you. If you are not currently contributing to the Integrits Corporation 401(K) Plan, an automatic deferral of 3% has commenced and will be contributed to your 401(k) Retirement account. If you do not wish to have an automatic deferral withheld from your paycheck, you have the option to opt out of the automatic deferral by emailing Vanessa Valdez. If automatic deferrals are withheld from your paycheck, you have 90 days to request the deferral and any earnings on those deferrals will be distributed back to you.

We strongly believe in investing in your Retirement, and we have added this new Automatic Enrollment feature in the hopes that we can contribute to your retirement via our Company match. A Feature like Automatic Enrollment helps ensure you can save enough to live comfortably in your sunset years. We are all aware solely relying on Social Security to provide retirement income can lead to insufficient savings when it comes time to retire. We believe the

automatic enrollment will help establish healthy savings and investing habits and will assist in gaining positive savings momentum when it's time to hang up your hat and enjoy all your hard work.

Again, if you are not ready to start deferring to your 401(k) account, you have the option to opt out of this feature. When you are ready, you can start deferring at any time during the year. Please feel free to reach out to HR with any questions.



Auto Enroll will commence on the February 2 pay date.




### 2023 W-2s Are Now Available


# W-4 Tax Withholding Review

Should you choose to make changes to your paycheck tax withholdings, login to your Insperity account and select "W-4" under the "Paycheck" section. Follow the instructions to submit your new W-4. Please note that you must submit your new W-4 no later than the Monday leading up to the payday for which you'd like your changes applied. For example, in order for changes to be reflected on your February 2 paycheck, they would need to be submitted by Monday, January 29.

# PTO Carry Over / Payout Options

Yesterday (January 17), HR distributed PTO Carry Over / Payout Option letters via email to Employees with unused PTO that was earned in 2023. Emails were sent to the Employee's primary email in SaaS.

Option letter responses are to be emailed back to Laura Villarreal no later than close of business Wednesday, January 24. If we do not receive a response from you, we will default to the Carry Over selection. Those opting to pay out their unused PTO earned in 2023 will receive those funds in the regular February 2 payroll.
