


REINTRODUCING OURSELVES

A MESSAGE FROM OUR SECURITY TEAM NICK ENRIQUEZ

Facility Security Officer (FSO) & Information Security Officer (ISO)

Our security posture at IntegrITS is integral to our everyday functions across the entire Company. To put it plainly, if we fail to follow security requirements and best practices, we are at risk of losing our customers—and more importantly, we put ourselves, our customers, and ultimately the Warfighter at risk.

In my role as FSO and ISO, it is my honor to ensure our Team is operating at the highest standards of excellence when it comes to security. I periodically send out notifications about emerging threats and other significant or potential risks to national security via newsletters, such as Purple Arrow: Daily Cyber Newsletter, and updated briefings about the latest Security Executive Agent Directive (SEAD) 3 reporting requirements. I hope you understand that these resources and updates are not mere formalities, as they provide key information regarding our national security that are helpful to know both for our work and personal lives.

Most of you have likely interacted with me in relation to my role supporting the Insider Threat Awareness program as well as conducting your Initial, Annual and Refresher Security Training. We've also likely worked together as I maintain and monitor personnel clearances to support our government customers.


Integrits Corporation was granted a Facility Clearance (FCL) after Defense Counter-intelligence and Security Agency (DCSA) determined the legitimate need to access classified information to support a government contract. DCSA has oversight authority and is responsible for inspecting and monitoring cleared companies to evaluate the security operations of the company. In this regard, DCSA manages the training and accreditation of the FSO to enable FSOs to remain compliant with the National Industrial Security Program (NISP).

On November 30, 2022, the DCSA Industrial Security Representative (ISR) led a security review with me to assess our security program's compliance with the new National Industrial Security Program Operating Manual (NISPOM) rules. IntegrITS passed the security review, and we were recognized as operating in general conformity with NISPOM.

The new Security Review Process is a compliance-first model that considers the whole Company's awareness and our overall cooperation within the security community. The effectiveness of our security program is subject to continuous monitoring to ensure our security controls remain suitable to counter current threats to national security assets. Security is an ever-evolving field, and we are working as an entire Leadership Team to put policies and procedures in place that will continue to strengthen our security posture.

A huge thank you to all of you who prioritize our security by keeping your knowledge up to date and implementing the policies that keep us safe. I look forward to working with you throughout the year!





As part of IntegrITS PTO Policy, at the end of each year we give employees the option to either rollover their current PTO balance into the new year or get paid for leave remaining on the books.
